#### For Women and Girls Visits the House of Sarah.






## House of Sarah Farewells Revd. Ann (and Roger)

# The House of Sarah goes to New Zealand

The staff at the House of Sarah has been invited by the Council for Anglican Women's Studies to facilitate their upcoming Hui at Vaughan Park Conference centre. The theme of the Conference will be: "Violence Prevention is Our Church's Business". The Hui gives the House of Sarah the opportunity to tell our story of the work we have been doing over the past few years and to learn about what has been happening in the church there and how we can move forward together.

#### House of Sarah Workshops in the West.

Clergy Workshop 'Safe Church and Interface between Biblical and theological teaching and human rights, gender equality and gender based

violence'



16 clergy from the Anglican, Methodist, Salvation Army, Assembly of God and Pentecostal Churches attend the House of Sarah Workshop at St Peter's Anglican Church in Lautoka in March 2015.

In discussing the UN Declaration of Human Rights and the UNESCO Declaration of Human Responsibilities he said that they did not clash with Biblical teaching as "God has blessed each and every child, boy, girl, man and woman with the right and responsibility to be human – or being human is everyone's birth-right" He also share the interpretation of Genesis 2:// which rather than saying God made women as a helper/companion that the correct Hebrew translation is that "God said I will make a power equal to Adam".

Rev Sereima introduced the
concept of 'Safe Church' and

Canon 1 Title D. This Code of

and church leaders. The

A brief introduction to gender analysis and counselling was conducted by the Nadi Women's Crisis Centre and basic pastoral care and where they can refer was covered by Nai Cokanasiga from the House of Sarah. The workshop provided some new insights and some challenging information but the response enthusiastic and House of Sarah was invited to return later in the year.

#### Sarah Carers' Workshop



In March 18 women from parishes in Sigatoka, Nadi and Lautoka were trained to be 'Sarah Carers' This included Bible study on the affirmation that God created women and men in God's image and gave them equal responsibility in stewardship of the earth. They also learned communication skills including active and non-judgmental listening skills and of the importance of self—care.

A doctor from the 'The Hub' women's health clinic share the resources available for women's health needs The police Sexual Assault Unit spoke about the law as it relates to family violence and rape. And the Nadi Women's Crisis Centre covered gender training, legal services and the family court procedures as well as the services they offer in counselling and support.

By the end of the workshop the women were equipped to offer support and referral options to women in their local parishes and communities who might be victim/survivors of family violence.
